# THE HON. LADY RAE K.C. Chair, SCSSA

Lady Rae is recognised as having led a distinguished legal career as a solicitor, advocate, Queen's Counsel, Sheriff, Vice Chair of the Parole Board for Scotland and an Upper Tribunal Judge in Immigration and Asylum cases. She retired as a Senator of the College of Justice in Scotland in 2020 but continues to sit part-time as a Judge. She was elected Rector of the University of Glasgow in 2021 and is the Vice Chair of St Margaret's Children and Family Care Society. Lady Rae is Chair of the SCSSA Board and is committed to ensuring that the agency will operate with "independence and integrity".

### PATRICK O'MEARA QAM Vice Chair, SCSSA

Pat O'Meara is a former strategic commander with the Scottish Ambulance Service. He also acts as Chief Medical Support Officer to the UK Army Cadets. He has served as a trustee of several charities. Dani has worked with the principles of listening and empathy as foundation stones in the leadership of complex services where the protection of others is of primary concern with much success and has embedded these same principles into the RLSS.

Frances is a Service Manager for Children's Services including Health Visiting and School Nursing. Prior to this, she worked for an NHS board as a Child Protection Advisor and her professional background is in midwifery and Health visiting.
